

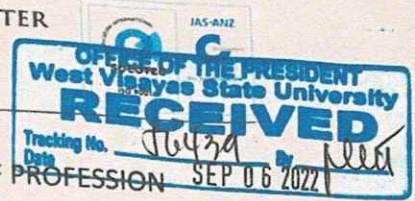

- A. State briefly the exact nature of proposed limited practice of profession and the reason/s for engaging in it. Explain how it will enhance service to the Medical Center.
As the Training Officer of the department and OIC Head of the Kidney Unit, my primary duties include guidance of the residents as they pursue their Internal Medicine training program and Administrative and Clinical management supervision of the IM Department and the Kidney Unit during my daily visits in the hospital which will sum up to 40 hours per week. I ask permission to follow up my private patients and also exercise my other private and corporate functions after doing my daily duties at WVSUMC. This will enrich and optimize my clinical management of our service cases and further train me in the administrative functions I am assigned to in this hospital.
