## **I. Call to Order**

Dr. Ferjenel Biron, Chairman of the Board called the meeting to order at 9:15 in the morning of June 30, 2023.

The Chairman stated that the Annual Stockholders Meeting is held via remote communication through the Zoom application and is being recorded in compliance with the requirements of the Securities and Exchange Commission. Before starting the meeting, he recognized the following directors, officers and guests : Dr. Amado Lavalle Jr. (President), Dr. Meride Lavilla (Vice Chairman), Dr. Danilo Regozo (Executive Vice President), Atty. Maylene Villanueva (Corporate Secretary and Compliance Officer), Dr. Agnes Villaflor (Corporate Treasurer), Mr. Elmer Samoro, (Chief Finance Officer), Atty. Analie Generoso, (Assistant Corporate Secretary), Mr. Lemuel Fernandez (Assistant Corporate Treasurer), Dr. Gerald Abonado (Hospital Administrator), Ms Toni Dinah Cheer Fernandez (Investor Relations Officer) other members of the Board and representatives of Dimaculangan and Dimaculangan (External Auditor).

## **II. Certification of Notice and Quorum**

The Corporate Secretary, Atty. Maylene Villanueva, stated that as required by the Securities and Exchange (SEC) and in compliance with the Revised Corporation Code and the Notice of the SEC dated 13 March 2023, the notice of the meeting was published in the business section of two newspapers of general circulation; The Manila Times and the Manila Standard in print and online format for two consecutive days. The last day of publication was 9 June 2023 is at least twenty-one (21) days prior to the date of the meeting. The Affidavits of publication executed by the respective authorized representatives of Manila Times and Manila Standards were then submitted by the Corporate Secretary for the record. In addition, the notice of the meeting was also posted at [www.apmc-iloilo.com](http://www.apmc-iloilo.com). She then certified that the stockholders have been notified of the meeting according to the company's by-laws and applicable rules including the internal guidelines in participation in the Annual Stockholders Meeting via remote communication and voting in absentia which are embodied in the Definitive Information Statement that the Securities and Exchange Commission approved.

The Corporate Secretary certified that there was quorum based on the tally of those who successfully registered online and validated proxies on hand, the number of shareholders present and in person and represented by proxy.

## **Rules of Conduct and Procedure**

The Chairman requested the Corporate Secretary to briefly discuss the rules for conduct and voting procedure of the meeting.

The Corporate Secretary mentioned that the voting rights of each stockholder and the requirements and procedures for participation by remote communication and voting in absentia has been set forth in the Definitive Information Statement. She highlighted the following points:

1. Stockholders who have successfully completed the registration and verification procedure on or before 28 June 2023 may participate in today's virtual meeting and shall be considered present for quorum purposes.
2. Stockholders who registered online or who notified the company via email to corpsec@apmciloilo.com of their intention to participate in this meeting via remote communication may send their questions and comments on Agenda Matters to the same email address. For the orderly conduct of meeting, these questions will be addressed later in the meeting. Questions received after 9:00 am will be responded to via email due to the time element involved in virtual meetings.
3. The matters submitted for voting in this meeting are as follows:
  - a. Approval of the Minutes of the 2022 Annual Stockholders' Meeting
  - b. Noting of the Updates on Construction
  - c. Approval of the Management Report and the Audited Financial Statement as of December 31 2022

- d. Ratification of all acts, transactions and resolutions of the Board of Directors and Management since the 2022 Annual Stockholders' Meeting
  - e. Election of Directors for 2023-2024
  - f. Appointment of External Auditor for 2023-2024
4. Voting in absentia is recognized in this Annual Stockholders' Meeting. Stockholders who had cast their votes for the proposed resolutions and Election of Directors for 2023 from 23 June 2023 to 28 June 2023 in the Online Voting Portal can still join the meeting and the polls shall remain open until the end of the meeting for stockholders who had successfully registered to cast their votes electronically in the Online Voting Portal.
  5. The initial votes have been tabulated after the end of the Proxy validation process and the preliminary canvassing for the VIAS. These votes are from stockholders owning 204,336 voting shares representing 100% the shares present in this meeting and 85.17% of the total outstanding shares of 239,870 shares. She mentioned that she would be referring to the results of the preliminary tabulation when she reports the voting results throughout this meeting. The results of the final tabulation of votes with full details of affirmative and negative votes as well as abstentions will be reflected in the Minutes of the meeting.
  6. Finally, she reminded the stockholders that the virtual meeting is being recorded in video and audio format in compliance with the requirements of Securities and Exchange Commission.

### **III. Approval of the Minutes of the Regular Stockholders' Meeting held on 29 September 2022**

The Chairman then proceeded with the approval of the Minutes of the Annual Stockholders' Meeting held on 29 September 2022. Flashed on screen is the resolution:

## **ASM Resolution No. 2023- 01**

RESOLVED, as hereby resolved that the Minutes of the 2022 Annual Stockholders’ Meeting held on 29 September 2022 be approved.

The Corporate Secretary mentioned that a copy of the Minutes of the Annual Stockholders Meeting in 2022 prepared in accordance with the requirements of the Revised Corporation Code was posted on the company’s website. The matters approved in the previous stockholder’s meeting were provided under Annex “F” of the Definitive Information Statement which was uploaded in the Company’s Website. For this reason, she proposed that they dispense with the reading of the Minutes of the 2022 Annual Stockholder’s Meeting and approve the Minutes as appearing in the company’s records.

The Chairman duly noted the proposal. He then asked if there are any inquiries received regarding the foregoing matter. The Corporate Secretary answered that there were no questions submitted via e-mail regarding the matter.

The tally of the votes and validated proxies on the adoption of ASM Resolution No. 2023-01 based on the total votes received, majority of the outstanding shares of the company present in the meeting providing for the approval of the 2022 Minutes of the Annual Stockholders Meeting held on 29 September 2022, was presented by the Corporate Secretary.

The Chairman mentioned that based on the report of the Corporate Secretary, the Minutes of the 2022 Annual Stockholders Meeting held on 29 September 2022 is approved. He then asked the Corporate Secretary to let the Minutes reflect the votes on the matter.

#### **IV. Updates on Construction**

The Executive Vice-President, Dr.Danilo Regozo, greeted the Chairman Dr.Ferjenel Biron, President Amado Lavallo Jr., the Board of Directors,

Founders, Stockholders and Guests , a good morning.

Dr. Regozo mentioned that they are at the final stage of construction with all overall percentage of 99.7%. He then presented the following percentage per discipline:

- Structural 100%
- Architectural Exterior 100%
- Architectural Interior 99.48%
- Electrical 99.4%
- Mechanical 99.5%
- Plumbing 99.26%
- Landscaping 100%

He added that they are presently on the Testing and Commissioning stage of construction with the following still on-going; air balance of the aircon system, synchronization of gensets, refinement in the building management system and snagging works of architectural fit-outs and all of these will be completed before end of July.

The challenges encountered for the past year were basically due to the new requirements of Department of Health in connection with the pandemic, and the delayed transport of materials and equipment needed for these requirements from abroad, an offshoot of the Russian-Ukraine War, he further added.

Dr. Regozo then proceeded to inform the stockholders that the hospital has nine (9) floors, a basement, one (1) dumbwaiter dedicated to the Nutrition and Dietetics Unit in the ninth (9) floor. Negative pressure ventilation systems are installed and tested in the ER, Pathology Department, Dedicated Operating and Delivery Rooms for Infectious cases in the 4th floor, COVID patients rooms in the 6th floor, and Isolation rooms in the 5th to 8th floors. Each room of both the Operating Room Complex and the ICU complexes are provided with Positive Pressure Ventilation system assuring sterility in these areas, except for the Infectious ICU where the opposite Negative Pressure Ventilation system were installed, ensuring preventive measures in the spread of infection.

Laminar Flow system have been installed and tested in the OR-DR complex. At the back of the main building is the Power House, within are (4) 1 MVA gensets, transformers and automatic switch gears. The basement, peripheral areas, and a 1-hectare lot at the back of the building will provide adequate parking spaces.

In the Basement the following are found: Engineering Office, Housekeeping Department, CCTV Room, Security Room , Warehouse , Central Sterilizing and supply room, IT Office, BIOMED Engineering Unit , Cadaver Holding area and the Behavioral Unit Ward.

In the Ground Floor are: the hotel like Lobby with Grand LED Wall, emergency room with a separate pedia and adult wings . In the Emergency Room (ER) are the Triage area, trauma room and a secured negatively pressurized glass-walled holding area for infectious cases, clinical laboratory with state-of-the-art instruments is connected to all Nurse Stations, Imaging Department which is divided into 2 wings ,the first wing with the CT scan room, MRI room, Floor mounted Xray room, Ceiling mounted Xray room and the portable X-rays are stored in the said wing.

In the other wing are the Mammography room, 2 Ultrasound rooms, Panoramic X-ray room, and the Fluoroscopy room. Pharmacy on the Ground floor was constructed along the ramp driveway in order to cater both inpatient and outpatient clients, and connected via Pneumatic tube system not only to the main Pharmacy on the 4th floor but also to all Nursing Stations, Operating Room Complex, Emergency room, and the ICU complex.

The Admitting Department, Cashier and Billing section, Customer's Relation office, and the convenience store are found on the other sections on the ground floor.

The 2nd floor is the Operating Room Complex which includes the following :3 Major Operating Rooms, 1 Cath Lab, 1 Optha Operating Room, 1 Minor Operating Room, 2 OB DR- CS Room and Post Anesthesia Care Unit. All operating fields in the Operating Rooms are provided with laminar flow ventilation thereby complying with needed sterility during procedures.

The Intensive Care Unit Complex is divided into 5 sub units with a total of 21 beds. These consists of the following: the Non-Infectious Adult, Infectious Adult, Surgical, Pediatric, Neonatal ICU, and a Stroke Unit. Also on the same floor are the following: the Endoscopy Room, Women's Center, Chapel, VIP Lounge for our Stockholders, Nursing Department Office, Ancillary Department, and Executive Vice President Office.

Located on the 3rd floor are the following: Eye Center, Cardiac and Neuro Center, Pulmo Center , Blood Bank, Breast-Feeding Station, a dedicated Operating Room and Delivery Room for infectious cases provided with Negative Pressure Ventilation.



The 3rd and 4th floors of the hospital are the Medical Clinic Offices with a total of 40 clinic rooms which can accommodate 160 Doctors per day. These offices can be converted to private rooms with minor architectural modifications if needed in the future.

The Rehab Center, Dialysis Center, Wellness Center, Dental Center and the Main Pharmacy and is provided with Pneumatic System connecting to all Nursing stations and Special Areas, are located in the 4th Floor.

The 5th to 8th floors consist of patients' rooms. The wall panels along the hallways are made of RMD boards which are chemical and impact resistant and expected to last for 20 years. All vinyl Floors are with antibacterial properties. All patient's doors are 1 hour fire rated while the main fire exit doors are 2 hours fire rated. In the 5th floor, are 4 beds in the step-Down ICU Room. The 6th floor have 7 beds in the Covid Wing.

A total of 28 Ward Beds. All the ward beds are in the 5th to 8th floor except for the Behavioral Unit ward which is situated in the Basement. There are 23 Semiprivate Rooms with 46 beds, 87 Standard Private Rooms, 31 Suite Rooms and 7 Presidential Suite.

The Executive offices, Administrative offices, Board Room, Grand Auditorium which can accommodate 400 guests and Café Nueve are found on the 9<sup>th</sup> floor.

Dr. Regozo then stated that the long wait is over and all can proudly say "It is worth the wait".

After his presentation, the Chairman thanked him. The Chairman then requested the Corporate Secretary to present the proposed resolution and the preliminary voting results.

The Corporate Secretary presented ASM Resolution 2023-02 Noting the Updates on Construction as proposed by the Management and the approval of the said resolution based on the preliminary voting results as shown on the screen.

## **V. Chairman's Message**

After greeting the founders and stockholders, the Chairman mentioned the opportunity of having this meaningful interaction in a formal setting not only with fellow investors but invited stakeholders of Asia Pacific Medical Center-Iloilo, Inc. He further stated that the Annual Stockholders meeting is a venue for the Board and Top Management to present the Management Report and engage the parties involved in the key issues confronting the Hospital, scrutinize the financial information from the previous year and respond to any question regarding concerns affecting the business of the Hospital.

The Chairman said that after years of countless delays in construction and three months into commencement of operations, the complicated and difficult task of redesigning an almost completed hospital into a pandemic-ready healing environment, he informed the stakeholders of the commencement of the commercial operations of the hospital on or before the end of September 2023. In addition, he also mentioned the hospital's inauguration and blessing last 28 May 2023.

One significant development this year is the approval of the registration of APMC Iloilo as a Domestic Market Enterprise engaged in Private General Hospital Activities by the Fiscal Incentive Review Board that makes the company entitled to six (6) years Income Tax Holiday, Five (5) years enhanced deductions and eleven (11) years duty exemption. With these incentives, he expressed his hope that the increased cost of construction as well as the rising interest costs will be off-set.

The Chairman expressed his immense gratitude for the confidence of the public especially the corporate stockholders who shared their company resources with the hospital for mutually beneficial arrangements. He added that regretfully for those who hesitated and waited for the completion of

the project, there are no longer shares to offer. He then shared a quote from Angela Duckworth: "Enthusiasm is common. Endurance is rare."

Global growth is projected to slow from an estimated 6.1 % in 2011 to 3.6% in 2022 and 2023. Global trade remains under pressure due to geopolitical tensions, wreaking global demand and tighter monetary and fiscal policies. Nonetheless, the Chairman expressed his optimism since the hospital industry can be a major economic driver as improved health enlarges the labor force and increases productivity. He added that while they expect to hurdle the effects of the global economic crisis once the hospital operates, the biggest challenge is the production and recruitment of health personnel. To broaden the recruitment base, he mentioned that the hospital entered into a Memorandum of Agreement with the University of San Agustin to be its base hospital for its College Health and Allied Medical Professions (CHAMP) and all related courses that they may offer in the future which may require a Base Hospital including a College of Medicine

The Chairman stated that as they explore more strategic partnerships and linkages in the coming years, the focus is on long-term growth and value-creating opportunities. To work on elaborate internal control while continuously improving and implementing best practices in hospital care, with the Operations Manual almost ready and meticulously reviewed while the core values, mission and vision remain the same.

He emphasized that they would not have made it far if not for the public investors who answered the call to build this legacy hospital. In closing, the Chairman shared the words from Henry Ward Beecher: " Hold yourself responsible for a higher standard that anybody else expects of you. Never excuse yourself. Never pity yourself. Be a hard master to yourself and be lenient to others". He then added: "that is our story and now that we have inaugurated and blessed our medical center, we begin the work to revolutionize healthcare in Iloilo and Western Visayas."

The Chairman then acknowledged the President, Dr. Amado Lavallo Jr. to render his report.

## **VI. Annual Report with AVP**

### **President's Report**

The President, Dr. Amado Lavallo Jr. welcomed the Chairman, Dr. Ferjanel

Biron, Officers , Board of Directors, stockholders, health professionals and guests to the 2023 Annual Stockholders' Meeting of APMC Iloilo. He then emphasized the presence of the attendees is a testament of their unwavering commitment to the growth and success of the organization, the deep rooted commitment to excellence in healthcare and the commitment to maintain transparency, accountability and good governance practice that will foster trust and confidence among the stockholders. He added that the meeting serves as an opportunity to provide updates on financial performance and plans.

As of May 15, 2023, the total percentage of completion of the construction of the multidisciplinary hospital is 99.7%. Several revisions were done in the various areas, including the Emergency rooms, Laboratories, operating and delivery rooms, among others to address the problems of COVID-19 which continues to be a concern. Safety facilities for infection control were installed including hepa-filters in the operating rooms and positive and negative pressure ventilations.

The hospital was designed to comply with the requirements of ISO-International Organization for Standardization and Joint Commission International which envisions a future of zero harm and highly reliable care delivery.

The various Medical Departments of the hospital have been organized and its Chairpersons have met with their respective staff and the Orientation of Policies have commenced. Highly qualified medical specialists established in their fields of practice and known in Iloilo and some from Manila, who made it to the cut after evaluation of the Credential and Privileging Committee will compose the Roster of medical experts and lead the APMC Iloilo medical team that will carry on the hospital's mission of Professional Medical, Personal Care. The flagship centers will soon be unveiled among which are the High Risk Pregnancy and Women's Health Center, Aesthetic Center, Regenerative Medicine Center. Also in the works are our Cardiac Cath laboratory, Eye Center and Oncology Center.

Of the 3,600 blocks or 36,000 shares that were allowed by the Securities and Exchange Commission for initial Public offering, that makes the subscribed shares at 239,870 shares with 14.91 % being owned by the public.

The Inauguration of APMC Iloilo took place on May 28, 2023, with construction activities focusing on testing and commissioning of finished works, as well as minor modifications and retouching of architectural finishes. The hospital management team actively working to meet the documentary and operational requirements set by the Department of Health for the hospital's License to Operate. Various departments are undergoing regular orientation and training in preparation for the implementation of a fully integrated Hospital Information System.

The Nursing Service Office have been conducting in-house training and actively recruiting additional nursing staff. The Medical Services Office is finalizing the roster of medical staff, including Junior Consultants and Hospitalists, who will be responsible for the different clinical departments and units once the hospital begins its operations.

Commercial operation is anticipated to begin on or before September 2023, pending compliance with all regulatory requirements. The hospital has submitted an additional loan request from the Landbank of the Philippines, which is still awaiting approval. The loan request includes additional working capital and a short-term credit loan to meet the cash requirements for the upcoming commercial operation. It also includes provisions for an additional loan facility for equipment purchases not initially included in the list.

The hospital currently has 255 employees. However, in order to meet the manpower requirements for the initial operation of the 100-bed capacity hospital, the plan is to contract a minimum of 694 employees by the end of year.

Among the highlights of the previous year and first half of 2023 are as follows: Testing and commissioning of CT scan, X-ray machines, mammography unit, and ultrasound units were completed in May 2023, worked with TIPP Plus for a fully integrated Hospital Information System, collaborated with IT consultants for network security and installation of hospital trunk line, intensive recruitment of employees of nurses started January 2023 to bolster human resource and conducting Open Houses and guided tours.

The President then presented the results of the operations as of the previous quarter and last year.

Changes in Financial Condition - March 31, 2023 vs March 31, 2022

The hospital is currently not operational, resulting in other income primarily coming from bank interests on deposits. Fluctuations in the balances maintained throughout the year contribute to the increase in other income. Despite not being operational, the hospital has incurred general and administrative expenses due to administrative and management transactions during the construction period. The expenses increased in March 2023, primarily due to higher salaries and wages as the personnel size increased fourfold compared to the previous year. To sustain construction and equipment acquisition, the company sought additional financial assistance, resulting in finance costs due to interest payments. As a result of being in the construction phase and not yet operational, the hospital has incurred losses. The expenses related to general and administrative costs and finance costs were higher in March 2023 compared to the same period in 2022, as reflected in the company's financial statements.

Notable are the Changes in Statement of Financial Condition March 31, 2023 vs March

31, 2022 such as:

#### ASSETS:

Cash balances have been kept relatively low due to prioritizing the construction of the hospital and payments for obligations and machinery. It is expected that cash figures will improve once the hospital starts operating.

This account was set up in preparation for the hospital's upcoming opening, expected this year.

Advances made to contractors and suppliers were recorded to account for down payments made by the company. As hospital construction progressed, the receivables increased. In March 2023, advances from contractors amounted to P60.4M, compared to P52.6M in March 2022.

In 2020, a significant portion of equipment and machinery was transferred to the hospital site in preparation for the planned opening that year. The advances account was reduced by P257M and included

in the company's assets. The ending balance for 2020 was P32M. In 2021, a downpayment of P3.5M to TIPP Plus was recorded. The year-end balances for 2021 and 2022 were P64.99M and P35.59M, respectively. In March 2023, additional advances totaling P38.98M were made to TIPP Plus.

The equipment were transferred to the hospital site in preparation for the opening of the hospital. As of March 2023, total PPEs (net) stands at P473M which was P41M higher than the previous year of the same period.

As of March 31, 2023, the total amount used for the construction of the building is P1.62B.

The accounts payable account consists mainly of Retention Payables, Government Liabilities, and Other Payables. As of March 31, 2023, the balance of the account is P105.1M, which is P17.M higher compared to March 2022.

The company borrowed money from Phil Pharmawealth, Inc. in June 2021, initially amounting to P11.83M. Additional releases were made thereafter, bringing the total loans to P246.4M as of March 31, 2023.

The company entered into a loan agreement with Land Bank of the Philippines for the construction and equipment of the hospital. The total loan amount is Php.1.06 Billion released in tranches. As of March 31, 2023, outstanding loans from Land Bank of the Philippines amount to Php.943.1 Million.

The premiums recorded from the sale of stocks during the IPO amount to P927.3M as of March 31, 2023. The price of the shares varied depending on the tranche from which they were purchased.

Since the company is still in the construction stage of the hospital, no operational income has been recognized. However, administrative and general expenses have been recorded since 2016, resulting in a total deficit of P224.37M.

The quick asset ratios for the three periods presented do not indicate a favorable number. This is mainly because the company's resources are currently being utilized for the construction of the hospital. As a result, the quick asset ratio is not at an optimal level.

Currently, the company's cash and other current assets are being used for the construction of the hospital. This utilization of resources has affected the current ratio, presenting less attractive information. However, it is anticipated that the current ratio will improve once the hospital begins its operations.

The company's long-term debts are fully covered by its equities. The figures indicate that the company's debt to equity ratio is favorable and improving, particularly due to the increase in sales of securities through the IPO.

The total obligations of the company account for slightly more than 50% of its resources. This indicates that the company's assets are increasing as the construction nears completion. While this may seem positive, it's important to note that the debts incurred for the construction of the hospital are still outstanding, and the hospital is yet to start operating.

The equity represents nearly half of the company's assets, which is a positive indication. This is mainly attributed to the proceeds from the sale of securities, which has significantly contributed to the funding of the hospital construction.

The company is at its construction stage, given so, payment of interests are dependent on funds generated thru sale of securities and not from income generated.

On April 14, 2023, the Asia Pacific Medical Center Iloilo was registered by the Philippines' Board of Investment as a Domestic Market Enterprise engaged in Private General Hospital Activities entitled to Income Tax Holiday for 6 years, Enhanced Deduction for 5 years and Duty exemption for 11 years. Benefits that will be derived from this registration is expected to offset interest expenses incurred and absorb the effects of inflation.

In closing, the President stressed to make a meaningful impact on the lives of patients, families, and communities. The success of APMC Iloilo will be a collective effort of every individual who is part of our extended family, including our dedicated employees, esteemed stockholders, and valued partners. He then expressed his sincere gratitude for the continued support.

## **Treasurer's Report**

After the President's Report, the Corporate Treasurer, Dr. Agnes Jean Villaflor presented the Audited Financial Statement which was also attached to the Definitive Information Statement.

The Corporate Treasurer mentioned the independent Auditor Dimaculangan, Dimaculangan and Co. CPAs appointed by the stockholders

during the 2022 Annual Stockholders' Meeting. She stated that after audit, the independent Auditor expressed their opinion that the financial statement of APMC Iloilo fairly presented in all material respect, the final position of APMC Iloilo as of December 31, 2021 and 2022. The financial performance, , the cash flow of the company for the year ended December 31, 2022, 2021 and 2020 is in accordance with the Philippines Financial Reporting Standard. The total assets of the company as of December 31, 2022 is 2, 024, 980, 690 at 9.67% increase higher from 1, 816, 986, 598 as of December 31, 2021.

After the Treasurer's Report, the Chairman inquired from the Corporate Secretary if there are any other matters that the stockholders must be informed of. In response, the Corporate Secretary answered that in compliance with the Revised Corporation Code, the stockholders must be informed of the total compensation received by each directors during the past year. Since the company is not yet operational, the Chief Finance Officer prepared a report on the per diems received by individual directors which was attached in the Information Statement together with a detailed Management Report that is compliant with the requirements of the Securities Regulation Code.

The Chairman then asked the Corporate Secretary to present the proposed resolution and the tally of the votes.

As the company is not yet operational, the Chief Finance Officer prepared a report on the per diems received by the individual directors which was attached in the Information Statement together with a detailed Management Report

which was compliant with the requirements of the Securities Regulation Code (SRC).

The Corporate Secretary presented ASM Resolution No.2023-03 and the tally of the majority of the stockholders owning outstanding shares present and voted in favor on the said matter.

### **VII. Questions and Answer**

The Investors Relations Officer, Toni Dinah Cheer Fernandez, stated that they have not received any inquiries or clarifications from the stockholders via email or chatbox as of 8 o'clock in the morning of 30 June 2023. However, the office of the Investment relations received questions via sms from the stockholders. Three relevant questions were taken from the sms inquires.

First question was from Joan Domingo who asked regarding when Asia Pacific Medical Center-Iloilo commence its commercial operations. The Chairman answered the inquiry wherein he stated that APMC Iloilo was inaugurated last 28 May 2023, an occasion to inform the stockholders that the construction is almost complete and indeed ready for commercial operations. He mentioned that the 200 nurses and other medical and non-medical staff were undergoing stringent training. Once all the licenses and permits from the Department of Health (DOH) the Food and Drug Administration (FDA) and the Iloilo City government , among others are approved, APMC Iloilo is then ready to operate. The expected date of commercial operations is September 2023.

The second question was from Ralph Geronimo who asked if the hospital fees are affordable to the stockholders and patients given that APMC Iloilo is considered to be the finest medical center and hospital of choice for most of the Ilonggos because of its modern and state of the art facilities. In response to the query, the Chairman answered that the management of APMC Iloilo ensures that all stockholders and the general public that it shall

remain competitive and reasonable with respect to all diagnostic and therapeutic services including cost of medicine and medical supply.

The Investor Relations Officer read the last question from Engr. Rena Gonzales asking of APMC Iloilo's plans to establish stem cell or regenerative center and cancer center and if these treatment services are available upon opening of the hospital. In response to the inquiry, the Chairman stated that the hospital will include in its services, the stem cell/ regenerative center and a cancer center including the new cutting-edge technology of using natural killing cell for stage 3 and stage 4 cancer, which will be the first in the country. The services should be made available by the end of 2023.

### **VIII. Ratification and Approval of All the Acts and Proceedings of the Board of Directors and Corporate Officers**

The Chairman proceeded to the next item on the Agenda which is the ratification and approval of all the acts, proceedings and resolutions of the Board of Directors and Corporate Officers since the 29 September 2022 Annual Stockholders Meeting as reflected on the Minutes of the Meetings of the Board of Directors. The summary of these acts, proceedings and resolutions were included in the Information Statement.

The Corporate Secretary presented the ASM Resolution 2023-04 and the tally of the votes, stating further that based on the total votes received, majority of the outstanding shares of the company present in the meeting voted in favor of approving all the legal acts, resolutions and proceedings of the Board of Directors and the Management of the Company from the time of the last Annual Stockholders' Meeting on 29 September 2022 up to the present date 30 June 2023.
